APPENDIX A

VERIFIERS STATEMENT OF POTENTIAL OR ACTUAL CONFLICTS OF INTEREST

- 4. Designing water sustainability projects which explicitly identify water credits or RoUs or water related green credits as a benefit.
- 5. Preparing or producing water-related manuals, handbooks, or procedures specifically for the RoU project activity.
- 6. Appraisal services of water stressed liabilities or assets.
- 7. Brokering in, advising on, or assisting in any way in water -related markets.
- 8. Management over health, environment and safety functions.
- 9. Legal and expert services unrelated to RoU verification for UWR purposes.
- 10. Verifier and Owner share board members or senior management.
- 11. If there is a financial, functional or structural link (e.g. common ownership, contractual arrangement, or informal contract) between the parties, whether directly or through affiliated organizations (e.g. holding companies, parent companies etc).
